

## **Conditions of Participation**

1. For the participation as exhibitor at the OMT 2018, the following conditions apply.

2. The application is binding and will be taken in account in order of in-payment. After applying you will receive a bill, after inpayment a confirmation of the exhibition areas.

3. The following payment modalities apply to the participation:

100% of the stand-costs with application, payable on receipt of bill 100,-€ deposit in cash at the beginning of booth build-up. This will be returned by the organizer on Sunday evening after leaving the exhibition area. The prerequisites for the refund are a booth breakdown not before 5:00pm, the return of the rented booth furniture and a tidy booth area.

4. The following payments are payable in case of cancellation or nonattendance:

cancellation before 09.02.2018 (10 weeks before beginning of the event)30% of the stand-costscancellation before 23.03.2018 (4 weeks before beginning of the event)50% of the stand-costscancellation before 13.04.2018 (1 week before beginning of the event)90% of the stand-costsNonattendance on the day of the event100% of the stand-costs

## Only after complete payment you gain the right to install the stand on the reserved area in the "Reithalle".In the case of non-payment, we reserve the right to re-let the space.

5. The organizer reserves the cancellation of the event for important reasons (death, severe illness, impossibility of realization etc.). An important reason is not the fill rate of the event. In this case the exhibitors will get back the already paid sums. Demands for expenditures (hotel, travel costs etc.) or compensation will not be possible.

6. The instructions of the staff of the "Reithalle", the organizer and his representatives have to be followed during the whole event.

7. The services of the organizer include the supply of the rented area, electricity as well as lighting of the hall (not the standlighting). There is only an organizer liability insurance. Apart from that liability for damages to property or actual loss exists only in case of intent or gross negligence. The organizer does not take responsibility for the exhibited goods.

8. Every exhibitor takes part in the event at his own risk and is responsible for all damages caused by himself, his staff or persons engaged by him.

9. The exhibitors are not allowed to run their own gastronomy with the purpose of sale. The exhibitors have to refrain from running single electric appliances such as heaters, coffee machines etc. (> 2 kW) except for the exhibition materials. We offer authentic gastronomy at a moderate price on-site. With regard to air quality there will be no cooking, frying or grilling in the hall itself. There's no smoking in the hall.

10. The exhibitors and the helpers (stand staff) will receive a non-transferable participant card, which entitles them to free entry to the hall.

11. Court of jurisdiction is Munich. Country of the event is Germany.
